A very big thank you to the Arawang Netball Association Executive Committee and their Volunteers for assisting Netball ACT to host Round 3 of the Capital Chemist Junior Championship competition. Without the assistance of these amazing volunteers we would be unable to deliver such an enjoyable competition and experience for all involved.

Event Staff will be wearing bright Orange Vests if you need any assistance or to speak with an official. Umpire Coaches will also be onsite assisting the umpires with their officiating and can be identified by their blue vests.

1. FIXTURES AND RESULTS

All fixtures and results are available through the My Netball App or via the Netball ACT website. Score updates will take place throughout the course of the day, please note these may be not be entered straight after the match but will be updated by the conclusion of the day.

2. EVENT PARKING

Event parking is located on the areas indicated in the below venue diagram. Please be aware in between games there will be many cars and pedestrians moving throughout the venue. As you enter and exit please be aware of your surroundings and obey all directions from the Event Marshalls.

The parking lot at Sherratt Place will be open but there is overflow parking off Fremantle Drive at Teesdale Place if needed. Parking on the grass off Streeton Drive may result in a ticket if we are unlucky enough to get a visit from an Inspector.



3. ARRIVAL AND TEAM ASSEMBLY AREA


Your District Association will confirm with you the time your athlete is required to meet at the Team Assembly area. The Team Assembly Area is indicated on the above event map on the oval beside the Arawang Netball Association courts 3 and 4.

4. COVIDSAFE ENVIRONMENT PLAN – CAPITAL CHEMIST JUNIOR CHAMPIONSHIPS

Netball ACT has in place a COVIDSafe Environment Plan for the competition. A copy of this plan is available on the Netball ACT website and all District Association Representatives and Event Staff have been briefed in the details of this plan. The safety of all participating members and the greater Canberra community is at the forefront of our decision making when finalising this plan.

Below is a copy of the venue layout regarding entry and exit points for players, umpires and team officials. To minimise over crowding around the entry and exit points Event Marshalls will assist teams with their movement to and from the courts. Spectators are requested to meet their teams and athletes pre and post game at the Team Assembly Area.

Post game teams will have 10 minutes to exit the venue, allowing 5 minutes for the next timeslot to enter and complete a 10 minute on court warm up.



5. A REMINDER ABOUT COVID-19 GENERAL HYGIENE

- Wash and/or sanitise hands upon entry/exit and before and after using toilet facilities.
- Wash your hands frequently, cover coughs and sneezes and dispose of tissues.
- Players are required to bring their own drink bottle, towel and other personal items as require
- Each team must supply their own hand sanitiser for players to use during the competition.
- Stay home if feeling unwell. If symptoms develop onsite notify the Netball ACT Competition Manager who will assist you to exit the venue. Upon departure seek medical advice and follow

the COVID-19 testing advice as per ACT Health Guidelines.

• ACT Government is **strongly advising** anyone who has been in specific locations identified by NSW Health on the specified dates to **quarantine immediately** and **get tested** for COVID-19 as soon as possible - even if you do not have any symptoms.

6. TEAM WELLNESS SURVEY

All teams will need to complete a Wellness Survey at all training sessions and prior to entering each venue of their fixtured match. Both Players and Team Officials are required to complete the survey. All teams will be required to submit a Team Wellness Declaration, citing that all players named and Team Officials have undertaken a wellness survey and have passed.

Team Manager's must submit the Team Wellness Declaration to the Competitions Manager upon entry to the venue. If a Player or Team Official answers YES to any of the questions in the wellness survey, they should not enter the venue and should go home and isolate.

7. CLEANING

Netball ACT and the host District Association will undertake a thorough clean each night prior to the venue opening for competition. Cleaning and spot checks will continue to happen throughout the day with post pads and netballs cleaned in-between matches.

8. SPECTATORS

We understand the ACT Government have provided Sport and Recreation further easing of restrictions around spectator numbers at events. To minimise the time required in between games and therefore reducing the overall length of the day. Netball ACT and host District Associations have agreed spectators will not be permitted past the entry gate of the courts.

The safety of the netball and greater Canberra community are at the forefront of this decision. After consultation with the District Associations, it has been determined we do not have the capacity within the limited timeframes of the day to implement COVIDSafe practices for both teams, officials and spectators. We thank you for your understanding of this and support for your athlete to participate in the competition.

Where possible please minimise the number of spectators attending the event for each athlete and/or team. Physical distancing will need to be maintained whilst at and moving around the venue. Spectators are reminded to always keep a minimum 1.5 metre distance between yourself/others and avoid common contact points. Event Marshalls will be reminding spectators of the physical distancing requirements throughout the day. Your cooperation and assistance with Event Staff is greatly appreciated.

9. COFFEE VAN & BBQ

A Coffee Van and BBQ will be onsite for spectators and participants to enjoy.

10. PUBLIC AMENITIES

Are located on the outside of the venue as indicated on the venue map.

11. FIRST AID

Netball ACT will have onsite a Physiotherapist to assist with First Aid treatment and response if it is required.
